SAUER-DANFOSS INC. ANNOUNCES AMENDED TENDER OFFER MATERIALS REGARDING INCREASE IN CASH OFFER PRICE TO \$14.00 PER COMMON SHARE

AMES, Iowa, April 12, 2010 -- Sauer-Danfoss Inc. (NYSE: SHS) announced today that it has filed Amendment No. 5 to its Solicitation/Recommendation Statement on Schedule 14D-9 and Amendment No. 5 to its Rule 13e-3 Transaction Statement, both originally filed with the Securities and Exchange Commission (the "SEC") on March 19, 2010, in response to the cash tender offer of \$13.25 per common share (the "Offer") commenced on March 10, 2010 by Danfoss Acquisition, Inc. (the "Purchaser"), a wholly owned subsidiary of Danfoss A/S ("Danfoss"). The amendments have been issued in response to the increase in the cash offer price with respect to the Offer to \$14.00 per common share announced by Danfoss and the Purchaser on April 9, 2010.

This press release is neither an offer to purchase nor a solicitation of an offer to sell securities. The Offer is being made pursuant to a Tender Offer Statement on Schedule TO (including the Offer to Purchase, the related Letter of Transmittal and other tender offer materials) and a Transaction Statement on Schedule 13E-3 filed by Danfoss and the Purchaser with the SEC on March 10, 2010, as amended.
